

OPERATION: RANCHO DELICIAS



After submitting an initial report on Las Delicias Ranch, Animal Recovery Mission (ARM) held a meeting with the Lee County Sheriff's Department to inform them of the illegal activity regularly taking place on the slaughter farm located in Fort Myers, Florida. Following the meeting, officials denied to take the case.

The USDA and Lee County agencies officially inspected all operations on the property to evaluate the way in which the animals are confined and slaughtered. After being informed that officials found no violations and were satisfied with the property's ongoing, ARM continued undercover investigations inside of the property to confirm that the state, county and federal official findings were correct.

The following report details ARM's new illegal findings of the operation, which are now even worse than before.

2016-2017 INVESTIGATION

In November, ARM investigators conducted long distance surveillance of Las Delicias Ranch, to evaluate customer and business activity. ARM immediately found that operations were running, customers were still purchasing animals to be slaughtered and pigs and other farm animals were being transported onto the property on both weekdays and weekends. ARM then continued undercover investigations inside of the property.

ARM undercover investigators entered the property on **December 23, 2016** at 1:00pm posing as customers and stayed for a short time, with the sole purpose of inspecting how the animals were being killed and the amount of business the operation received. The property was very busy on this day, with north of 75 customers purchasing animals for human consumption. Undercover investigators walked up to the pig holding area and witnessed a pig being stabbed to death, unstunned. ARM had not seen this type of pig kill on their previous visits to the property. On all other visits, the pig would first be shot and then stabbed in the heart, but on this day, there was no gun being used. Pigs were being stabbed and killed in front of roughly 30 other pigs who were in the same holding area and were cowering out of fear in the corner. Then, once the animal was dead or dying, the other pigs would race up and drink the blood draining from its body. This was not an uncommon visual for ARM investigators, as this was witnessed upon each visit to the farm. The pigs were doing this out of desperation for sustenance because there was no food or water available for the animals in sight.

During this visit, there were north of 200 pigs who were confined to several extremely unsanitary holding areas. The pigs were coughing and looked to be unhealthy and possibly diseased. Due to ARM's history of working alongside Florida Department of Agriculture head veterinarians and USDA head veterinarians, we believe that many of the pigs had Brucellosis and Swine Flu. Along the back of the holding areas, investigators saw traces of dead, butchered animals and entrails which seemed to have been fed to the pigs. Inside of the butcher area, ARM witnessed and documented goats being hogtied, struggling, showing obvious signs of stress and pain, and laying amongst dead, dying and other animals being butchered.

On this day, there were no signs of the head butcher and co-owner, Alex, of whom ARM investigators usually dealt with. ARM would also like to note that according to USDA regulations, it is illegal to butcher animals in front of other animals.

ARM investigators visited the property again on **December 30, 2016** at about 1:30pm posing as customers to evaluate the farms customer loads and animal kills and stayed inside the property for about two hours. The property was busy this day with constant customers entering and purchasing animals.

There were an estimated 150 pigs in holding areas around the property which clearly had not been cleaned since ARM's last visit and were still extremely unsanitary. ARM investigators scanned the property for food or water but found nothing in sight. ARM noticed dying and already deceased pigs living amongst live ones. There were also some pigs who had their heads wedged between the floor boards and had looked to be stuck there for some time, while still alive.

In some of the pig areas and towards the back of the property, ARM recorded several horses who most likely were there for slaughter purposes. Their holding areas were littered with trash, animal excrements and dead carcasses. The horses looked extremely emaciated and sickly, and seemed to be in areas that were purposely hidden from public view.

Undercover investigators spoke with Ayme, owner, operation manager and wife of Alex, about purchasing a pig and negotiated a price of \$225 as well as \$30 for 2 chickens, which included the killing and cleaning fee.

Ray, one of the main animal killers and regularly working employee, took 2 chickens from their holding area and brought them into the butcher area. Without stunning them first, he slashed their throats with a knife one by one, and then threw them into a garbage can to thrash about and bleed out.

The pig that ARM purchased was chased down by the butcherer and thrown to the ground. He then stabbed the pig in the heart with a foot long blade, in front of about 20 other pigs who were seen cowering in the corner. The pig was left to bleed out for a bit and was then taken into the butcher area for slaughter. The majority of the pigs are being dragged by a long, sharp, needle-point like tool, while still alive, to the main butcher area and tubs of boiling water. ARM believes that the main man killing the pigs on this day is from Miami and is used to killing the pigs without stunning them first.

During this visit, ARM witnessed 3 pigs, purchased by other customers, who also had been stabbed without being properly stunned first, and 6 were shot first and then stabbed. There was a total of 9 felony pig kills that were captured by ARM undercover investigators on this day. Investigators also witnessed 17 fowl that were killed without being properly stunned. Ayme was well aware of the way in which the animals were being killed because she was seen monitoring the butchers and telling them that they were not working fast enough.

After the animals were loaded into ARM's undercover truck, investigators left the property.

ARM investigators visited the property again on **January 26, 2017**, at about 12:30pm with the purpose of inquiring about purchasing horse meat. ARM speculated that employees were slaughtering horses and selling horse meat because of overheard conversations from the owners and because there were emaciated horses hidden on the property in areas mixed with pigs and other farm animals.

Undercover Investigators could not find Ayme or Alex on this day, and ARM took note that Alex had been missing from the property since ARM's March 2016 visit. Investigators approached Ray and a man who goes by the name of Roman, and asked where they could find Ayme. Ray then directed them to a man named Carlito, one of the main cooks at the on-site cantina, who called her from his cell phone. ARM investigators told Ayme that their daughter was anemic and not doing well on her current medication and were informed that horse meat could help aid anemia. Ayme immediately instructed Carlito to sell 20 pounds of horse meat to ARM undercover investigators and promised to sell it to them as needed. Ayme asked that investigators call the horse meat beef, instead of horse, because it is illegal to kill horses and sell their meat. ARM then concluded that she is well aware of the law. The phone conversation was not recorded.

The horse meat was packaged in 2 separate bags. The first bag had 10 pounds of meat in it and was sold to ARM at \$4 a pound. It had the word "Muslo" handwritten on the bag, which means horse meat from the back of the thigh. Because the label was handwritten, it can be used to match the handwriting to an employee of the farm. The second bag contained 10 pounds of horse ribs, which was sold at \$3 a pound. ARM investigators also purchased 2 chickens whose throats were slashed, un-stunned by Ray and left to bleed out in the same cruel manner as ARM's previous visit. Investigators paid for the horse meat and the chickens, which were loaded into ARM's undercover truck and they left the property.

Investigators also documented other customers visiting the property this day.

On **January 29, 2017**, ARM sent the horse meat that was purchased on the 26th, to Elisa Technologies Laboratory in Gainesville, Florida for testing. This laboratory tests all of the horse meat purchased from ARM's undercover investigations throughout the state of Florida. Three days later, ARM received an email from the laboratory, declaring that both bags of horse meat purchased from Las Delicias Ranch tested as positive equine meat. Kudo immediately called a head of the USDA Food Safety Division for the South Eastern part of the United States, and informed them that cruel and inhumane slaughter of animals, including horses was regularly occurring on this property and of the new horse meat test results. Kudo also asked that the USDA contact the Lee County Sheriffs Department and State Attorneys Office to inform them of the violations existing on this illegal operation.

On **March 30, 2017** ARM again entered the farm to confirm they were still in operation. ARM workers were approached a farm employee and inquiries were made to purchase 2 chickens for humane consumption. After catching 2 poetry in the back cages the birds were quickly carried into the slaughter building. The birds were held over a trash barrel and there throws slashed un stunned. The birds were then thrown atop of one another to suffer and bleed out. Soon after the animals were then boiled and gutted for packaging. Groups of awaiting customers were also purchasing chickens and ducks for humane consumption. A second ARM worker then requested

the sale of horse meat. The cook know to ARM as Carlito placed a call to Amie (owner) whom was off site at the time. After confirming she new us Amie then instructed Carlito to packed the meat for sale. ARM workers spoke to Carlito confirming that he was aware the meat was being sole for humane consumption and that he was aware it was horse meat. ARM then left the property after confirming the business was still up and running. Soon after ARM sent out the horse meat for testing and again the results were positive equine.

While ARM awaited a response from official agencies about this case and after weeks of speculating where Alex, the self-described owner of the operation, had been, ARM found out that a man named Ivan Alberto Hernandez-Madrigal, who has the same physical description, photo, address, age, height, weight and last name as Alex, was arrested at Las Delicious Ranch and is currently in jail. According to the booking details gathered from the Lee County Sheriffs Departments website, this man was arrested on 7 felony charges of fraud and swindle, on June 13, 2016 at 4:00pm. His booking ID is 300563 and his address on the website is 7161 Eastwood Acres Road Fort Myers Florida, 33905 which matches the address at Las Delicias Ranch. ARM concludes that this may be Alex.

These are his charges according to a press release from the Department of Financial Services:

- Stole more than 1 million dollars through payroll check cashing in a workers compensation scheme
- Racketeering
- Crimes against person (\$50,000 or more)
- Money laundering (\$100,000 or more)
- Workers compensation stop order (\$100,000 or more)
- Utter false instrument
- Out of county warrant (perhaps wanted in Broward County)

The owners of this property also have a lengthy track record for violating Lee County ordinances, including:

- Building and zoning without proper license
 - Notice for clearing agriculture illegally to expand their business
 - Selling beer and food illegally
 - Running an illegal bar on the property
 - Running an illegal restaurant on the property
 - Charged for pumping waste from their slaughter house into neighboring properties
 - Running business without license

- Slaughtering hogs without an Ag exemption
 - Busted for running a restaurant in an Ag 2 zone
 - Flooding waste into adjacent properties
 - Parking and storing commercial vehicles (Semi trucks)

None of the businesses on this property are incorporated and the owners are running this operation without an LLC or insurance. According to the Florida Department of Business & Professional Regulation (DBPR) official website, they are also considered a non-licensed business. The USDA, has stated that this operation is a Custom Slaughter Exempt Slaughterhouse. This means that by USDA standards, they are considered legal and have been overseen and inspected by USDA veterinarians and Food Safety Investigators. However, they are killing animals using extremely inhumane and illegal methods and are blatantly violating their exemption, including state law.

These are their possible violations:

- Slaughtering animals using inhumane methods
- Selling adulterated meat
- Confining animals to unsanitary holding areas
- Inhumane dragging of animals to slaughter
- Hoisting animals alive for slaughter
- Skinning animals alive
- Slaughtering animals using inhumane methods in front of the other animals
- Pigs eating entrails and drinking blood from newly slaughtered animals (going back into the food chain)
- Environmental laws (illegally disposing of animal carcasses, pumping animal excrements throughout the grounds of the property and into neighboring properties)
- Throwing bleeding and dying chickens in trash barrels among live ones awaiting slaughter.

Other than ARM's independent undercover investigations of this property, ARM is not aware of any other undercover investigations conducted by state, county or federal agencies. The only way these agencies would investigate and monitor the property undetected was from street side, where there is little to no view of any animals or the butcher and slaughter area. When any of these agencies did enter the property, they would be in uniform and would announce who they were, which compelled employees to slaughter animals in a more approved manner. This left official agencies satisfied with how animals were being killed. It was not until ARM went into the property undercover, that evidence of inhumane animal slaughter and illegal activity was documented.

Kudo spoke with the Lee County State Attorney's Office and Lee County Law Enforcement and requested to meet with their Organized Crime Unit. ARM has worked with the Organized Crime Unit in various counties and knows that they have the experience to handle these cases.

However, Lee County, said that this unit had been dismantled. Kudo then asked to meet with Lee County's Narcotics Undercover Unit, whom ARM has also worked with in other counties, due to their knowledge and skills in conducting undercover investigations. Instead, Kudo was sent to Lee County's Agriculture Patrol Unit for case handling.

Recently, several cases of stolen pet horse slaughter and findings of dumped horse carcasses, similar cases which ARM investigates in Miami, have been reported in the area of Lehigh Acres, Lee County, Florida. This location is in very close proximity to Las Delicias Ranch and is where Alex and Ayme are documented to have lived for over 6 years. The couple is familiar with this area and quite possibly may be involved in these horse slaughter cases.

Following ARM's undercover horse meat buy at Las Delicias Ranch, the USDA asked the Lee County Sheriff's Department to collaborate with ARM and conduct a joint operation horse meat buy which the USDA would then send to their laboratories in Washington DC for testing. When the tests come back as positive equine, the USDA would hand the felony case over to the State Attorney's office for prosecution. Although this method has been proven to work in the past, the Sheriff's Department said they wanted no part of this case because it would not work in their county. The USDA confirmed ARM's credibility and that they have collaborated with ARM on multiple cases which concluded in operation raids and arrests, and that this method would work in any Florida County.

ARM has conducted over 140 independently run investigations from start to finish without governmental support and has submitted investigative evidence to local law enforcement, federal officials, and official state agencies. ARM has executed this in 5 different counties in the state of Florida, which has led to felony arrests, business and farm closures, tactical raids, and the rescue and seizure of all tortured animals. Stemming from these cases, many offenders have been tried in court, and are now convicted felons. ARM's cases have also created new case law in the state of Florida which will certainly help with the case of Las Delicias Ranch illegal slaughter farm in Lee County, Florida.

Audio and video laws have also been contested in a court of law by judges and juries who have ruled in favor of the prosecution, allowing both of ARM's undercover video and audio to be used in trial. ARM investigators have been used as affiants, co-affiants and as main witnesses in trial and since 2015, 6 illegal operations were raided, closed, all animals had been rescued, and over 17 people were charged with felony animal cruelty stemming from those cases. Lee County Agriculture Patrol Unit assisted in 3 of those raids which were located in Palm Beach County and were independent investigations thoroughly conducted by ARM from start to finish.

Besides the Animal Recovery Mission, other animal defense organizations have documented felony animal abuse on various properties in the state of Florida and delivered that evidence to various county Sheriffs Departments, which then led to felony arrests, property raids, and animal rescue seizures, such as in Pasco County in 2016. Therefore, it is not uncommon for civilians to hand deliver criminal evidence to law enforcement. This type of case execution should not be

foreign to this county, county officials and governmental departments. ARM is still hopeful that Lee County officials will reconsider taking this case, which is possibly the worst felony animal cruelty case in the history of Lee County, Florida.

ARM investigators are very seasoned in these types of undercover investigations and organized crime operations. ARM investigators make for credible and reliable affiants and witnesses and will assist in the case however needed. The Florida State Attorneys whom ARM has worked with in the past, will also aid in this case if need be.
