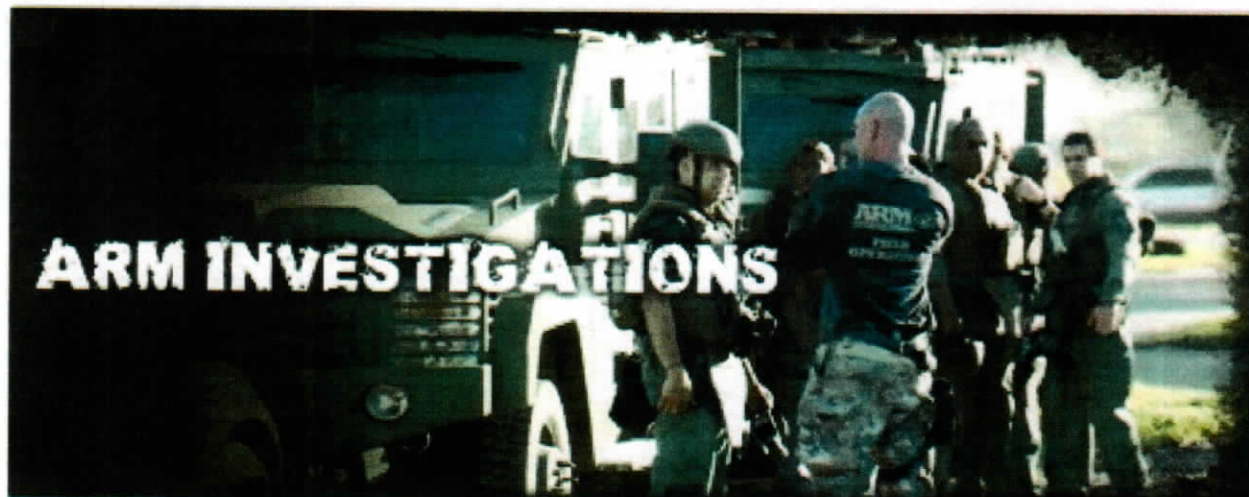

ANIMAL RECOVERY MISSION



Established in 2010, The Animal Recovery Mission (ARM), is a non profit investigative organization dedicated to eliminating extreme animal cruelty operations worldwide. ARM stands out as a vanguard and uncompromising defending force for the welfare of animals. In addition, ARM strives to put an end to, and preventing pain, suffering and torture as a result of inhumane practices.

The mission of the organization is to implement direct-action tactics to investigate, document and expose illegal activities of extreme animal cruelty. The organization's primary goals are to improve the quality of life for animals and to educate the public regarding animal cruelty, the practices that contribute to animal cruelty and the illegal animal slaughter. Achieving these goals contribute to an increased awareness of the unforeseen ethical, social and environmental implications of animal abuse and produce effective changes in the treatment of defenseless animals.

Animal cruelty investigations taken on by ARM operatives include, but are not limited to; animal slaughter farms, animal sacrifice operations, illegal horse sales and slaughter, and animal fighting operations. In addition, ARM is focusing upon the pressing issues and concerns of animal welfare within the animal agriculture and factory farming sector.

Since 2010, ARM's undercover investigations have led to the closure of up to 138 illegal animal cruelty operations in the state of Florida alone. The following report provides detailed findings gathered during ARM's investigation of a dairy farm located in Ockeechobee Florida-known as Larson Dairy.

Summary Of Investigation



ARM Investigators discovered an illegally operated slaughter farm known by the name Rancho Cabrera. The slaughter farm is located at 15729 43rd Rd N, Loxahatchee (Palm Beach County) FL. The property was discovered while Investigators were conducting an investigation in the area. There are no posted signs or markings near the property to show that it is an active business.

On Feb 08th 2018 ARM Investigators entered the property. They made contact with property and business owner, Ricardo Cabrera. They were invited to the rear of the property where they were able to purchase multiple live birds. ARM Investigators also attempted to purchase an animal for slaughter but were told that they would have to return on the weekend.

On February 10th 2018, Investigators returned to Rancho Cabrera and made contact with Ricardo Cabrera (goes by Ricky) and an additional Hispanic W/M (approximately 70yoa and goes by Roberto). Investigators walked throughout the property and observed several pigs living within sections containing no available food or water. Animals appeared to be sick and malnourished.

On this date, Investigators also observed a silver Ford pickup truck with an animal trailer attached to it. Inside the trailer were live pigs all laying on the ground. The interior walls of the trailer and the floors contained fresh blood splattered all over. The pigs inside appeared to be suffering from heat exhaustion and possibly dehydration. It is unknown how long the pigs had been contained within the trailer without water and food.

Investigators, acting as customers, purchased one goose and one pig for slaughter. The goose was placed into a small wire box by the unidentified hispanic male. The goose was not able to stand, raise its head or move freely. The goose was confined into a box in a cruel and inhumane manner. The ARM Investigators later selected a pig to be slaughtered with "Ricky". After the selection, Ricky approached the pig and shot it once in the head using a small caliber rifle. The pig dropped to its belly but continued to struggle. Ricky then used a knife to stab the pig in the neck/chest area. The pig continued to show signs of life for approximately 2 minutes. It was later dragged to the butchering area located within the rear of the property.

While on the property, ARM Investigators observed several other customers including children playing near the butcher site. Customers were observed killing the chickens themselves. They were filmed cutting the necks of the chickens and then placing them into nearby tall containers. As the neck of the chickens were cut, they continued to show signs of life inside the container as they bled out for an extended period of time. At no point were they made insensible to pain.

On March 29th 2018 an ARM Investigator entered Rancho Cabrera posing as a customer. On this date, the Investigator spoke to an employee who identified himself as Roberto. The Investigator asked for two slaughtered chickens. Roberto retrieved two chickens and brought them into the slaughter area. Roberto grabbed a knife and cut into the throats of the chickens. While they were still alive, he threw them into a large 55 gallon drum. The chickens showed clear signs of life and struggled to breath for several minutes due to the improper method of slaughter.

On April 18th 2018 an ARM Investigator returned to Rancho Cabrera posing as a customer. On this date, the investigator spoke to a female employee who identified herself as Katie (hispanic female, approx. 45yoa and approx. 4'8"). Katie retrieved the two chickens and brought them into the slaughter barn. She placed the birds over a 55 gallon drum and made a small incision to the throat of each bird. Katie then released them into the drum and allowed them to die slowly. The chickens showed clear signs of life and struggled to breath for several minutes due to the improper method of slaughter.

On April 25th 2018 an ARM Investigator returned to Rancho Cabrera posing as a customer in order to purchase a goat for slaughter. The ARM Investigator met with a white male (approx. 33yoa, approx. 6'3") who identified himself as the son of Ricardo Cabrera (property owner). Another employee also referred to him as the owners son. On this date, the investigator selected a goat for slaughter. The white male employee retrieved a goat from the holding area. The white male dragged the goat into the slaughter area and without warning, cut into it's back legs with a knife. It should be noted, that during this described incident, there were several bystanders/customers nearby including children.

The white male along with a hispanic female employee lifted goat in the air and hung it upside down on meat hooks while still alive (violation of FL State Statute 828.24(2)). The goat was hung from the cuts in it's back legs. The white male then used the same knife and cut into the throat of the goat. At no time did the white male attempt to make the goat insensible to pain as defined in the humane slaughter act either by gun shot or . The goat then began to struggle for it's life by moving it's body. The goat could be seen attempting to breath, as its stomach moves inward and outward.

On this same date (April 25th), the ARM Investigator observed Roberto, Katie and the unidentified W/M slaughter approximately 200 chickens in the same manner described above on previous dates.

On May 23rd 2018 an ARM Investigator arrived at Rancho Cabrera and purchased a sheep for slaughter. Again, the investigator met with the white male who identified himself as Ricardo Cabrera's son. The white male walked the investigator to the area where the sheep were being

held. After a sheep was selected, the white male used a small caliber rifle to attempt and shoot the sheep in the head. The white male stood approximately 10 yards away and fired the rifle. The shot grazed the sheep in the face. The sheep then ran to the remaining herd within a shed area. The white male chased after it and cornered the sheep. He then used the knife to saw into it's neck. The sheep was then placed into a wheel barrel while still showing clear signs of life. The white male transported the sheep to the butcher area. The sheep then began to kick so fiercely that it tipped over the wheel barrel. The sheep continued to struggle for it's life for approximately 7 minutes. While still alive, the white male began to place meat hooks into the back legs and raise the sheep into the air.

A records check of Palm Beach County and the State of Florida showed that Rancho Cabrera is not listed as a business. No business permit has been located for Rancho Cabrera in Palm Beach County. Rancho Cabrera is not listed with the USDA as a custom exempt slaughter farm.

When humanely slaughtering poultry, you must decapitate the the bird in one swift movement with a sharp knife or axe so that all Cerebral Spinal Fluid escapes from the cut spinal cord. Cutting into the throat of the bird (by cutting the blood vessels) will allow it to stay conscious. The bird will stay conscious and suffer for 3 to 4 minutes. Leading poultry purchased from Rancho Cabrera to be boiled alive and susceptible to unnecessary pain and suffering. This is an unacceptable and inhumane way to slaughter poultry defined by several Veterinarians (Dr. Mike Petrik, and the American Veterinary Medical Foundation).

Several days of mobile surveillance were conducted of vehicles leaving Rancho Cabrera and traveling around the tri-county area (Palm Beach County, Broward County and Miami Dade County). Several customers were observed leaving the property and traveling to different locations delivering slaughtered chickens purchased from Rancho Cabrera. Slaughtered chickens were delivered to residences as well as businesses. Surveillance of customers began after several individuals purchasing chickens stated that they were restaurant owners.

828.12 Cruelty to animals.—

(1) A person who unnecessarily overloads, overdrives, torments, deprives of necessary sustenance or shelter, or unnecessarily mutilates, or kills any animal, or causes the same to be done, or carries in or upon any vehicle, or otherwise, any animal in a cruel or inhumane manner, commits animal cruelty, a misdemeanor of the first degree, punishable as provided in s. 775.082 or by a fine of not more than \$5,000, or both.

(2) A person who intentionally commits an act to any animal, or a person who owns or has the custody or control of any animal and fails to act, which results in the cruel death, or excessive or repeated infliction of unnecessary pain or suffering, or causes the same to be done, commits aggravated animal cruelty, a felony of the third degree, punishable as provided in s. 775.082 or by a fine of not more than \$10,000, or both.

(a) A person convicted of a violation of this subsection, where the finder of fact determines that the violation includes the knowing and intentional torture or torment of an animal that injures, mutilates, or kills the animal, shall be ordered to pay a minimum mandatory fine of \$2,500 and undergo psychological counseling or complete an anger management treatment program.

(b) A person convicted of a second or subsequent violation of this subsection shall be required to pay a minimum mandatory fine of \$5,000 and serve a minimum mandatory period of incarceration of 6 months. In addition, the person shall be released only upon expiration of sentence, is not eligible for parole, control release, or any form of early release, and must serve 100 percent of the court-imposed sentence. Any plea of nolo contendere shall be considered a conviction for purposes of this subsection.

(3) A person who commits multiple acts of animal cruelty or aggravated animal cruelty against an animal may be charged with a separate offense for each such act. A person who commits animal cruelty or aggravated animal cruelty against more than one animal may be charged with a separate offense for each animal such cruelty was committed upon.

(4) A veterinarian licensed to practice in the state shall be held harmless from either criminal or civil liability for any decisions made or services rendered under the provisions of this section. Such a veterinarian is, therefore, under this subsection, immune from a lawsuit for his or her part in an investigation of cruelty to animals.

(5) A person who intentionally trips, fells, ropes, or lassos the legs of a horse by any means for the purpose of entertainment or sport shall be guilty of a third degree felony, punishable as provided in s. 775.082, s. 775.083, or s. 775.084. As used in this subsection, “trip” means any act that consists of the use of any wire, pole, stick, rope, or other apparatus to cause a horse to fall or lose its balance, and “horse” means any animal of any registered breed of the genus *Equus*, or any recognized hybrid thereof. The provisions of this subsection shall not apply when tripping is used:

828.13 Confinement of animals without sufficient food, water, or exercise; abandonment of animals.—

(1) As used in this section:

(a) “Abandon” means to forsake an animal entirely or to neglect or refuse to provide or perform the legal obligations for care and support of an animal by its owner.

(b) “Owner” includes any owner, custodian, or other person in charge of an animal.

(2) Whoever:

(a) Impounds or confines any animal in any place and fails to supply the animal during such confinement with a sufficient quantity of good and wholesome food and water,

(b) Keeps any animals in any enclosure without wholesome exercise and change of air, or

(c) Abandons to die any animal that is maimed, sick, infirm, or diseased,

is guilty of a misdemeanor of the first degree, punishable as provided in s. [775.082](#) or by a fine of not more than \$5,000, or by both imprisonment and a fine.

(3) Any person who is the owner or possessor, or has charge or custody, of any animal who abandons such animal to suffer injury or malnutrition or abandons any animal in a street, road, or public place without providing for the care, sustenance, protection, and shelter of such animal is guilty of a misdemeanor of the first degree, punishable as provided in s. [775.082](#) or by a fine of not more than \$5,000, or by both imprisonment and a fine.

828.24 Prohibited acts; exemption.—

(1) No person shall kill an animal in any way except by an approved humane method.

(2) No person shall shackle or hoist with intent to kill any animal prior to rendering the animal insensitive to pain.

(3) Nothing in this section precludes the enforcement of s. [828.12](#) relating to cruelty to animals.

Narrative

Crime scene:

The Cal-Maine Food layer house located at 1803 Tindel Camp Road, Lake Wales, Florida.

On 01/03/18 the group, Animal Recovery Mission (ARM) contacted the Polk County Sheriff's Office about a possible animal abuse/neglect incident at a local chicken farm (egg production). The farm houses approximately 600,000 chickens for egg production. The farm is owned by Cal-Maine Food. An employee of A.R.M., [REDACTED] delivered the complaint. It alleged the company was allowing employees to abuse the chickens by stabbing and striking them with broken sticks, not providing sufficient food or water, and allowing 100-900 chickens per day to die. The group provided me with a book of photographs and a letter explaining what they alleged. They also provided a video which appeared to be taken by an employee using a hidden body camera. This video showed employees herding chickens on the bottom floor (the bottom floor is where the chicken feces accumulates so if a chicken gets loose and ends up on this floor, it must be euthanized). Once the employees got the chickens to a corner they began to grab them one by one and euthanize them by cervical dislocation (state approved euthanasia method). During this incident several employees were holding sticks and using them to herd the chickens to the corner. At one point on the video, one employee, Matthew Faulkner uses his stick to strike several chickens with force. This employee missed several times and struck one of the chickens rendering it immobile. The video also showed numerous chickens in pens as well as roaches gathered on the feces trays. There was no audio on the video that was provided to the Sheriff's Office.

On 01/04/18, I responded to the incident location with two State of Florida Veterinarians employed by the State Department of Agriculture, Dr. Wolf and Dr. Fernandez (inspectors of egg facilities for the state). Contact was made with the Vice President of Operations, Kevin Lastowski who stated he wanted to cooperate fully with the investigation. Management identified the employee that was striking chickens with the stick and stated he was trained to euthanize a chicken using cervical dislocation and provided his training records. Kevin Lastowski also invited me and the veterinarians to inspect the property, facility and any other area we wished. Members inspected the chicken houses and facility to find no violations of criminal law. State Veterinarians also stated they did not find any violations of health as well. Kevin Lastowski also provided the water and feed consumptions for the past three months which showed proper water and feed to all the animals on the property. He also provided the mortality rate sheets which showed a normal mortality (08-80 per day) for the past three months (confirmed through the State Vets). Allegations of Cock roaches covering the facility were found to have occurred but Kevin Lastowski stated when they were found they were eradicated by state approved means. A search of all of the chicken houses was done with no roaches observed. During the inspection thousands of cages were observed. All cages observed had an ample supply of feed and an functioning automatic water source. The facility was well lit with lights was well ventilated with large ventilation fans on the ends of the houses. A copy of Dr. Wolf's State Vet report is attached as a page of this report giving the facility a clean bill of health after the full inspection was completed.

The employee that struck the chickens in the video, Matthew Faulkner W/M 08/27/79, was not at work on this date. I responded to his residence to find he was out of town until 01/05/18. On 01/05/18 I made contact with Faulkner at his residence. I explained to Faulkner why I was there and what the complaint was about. Faulkner remembered the incident and advised he was stupid and made a bad decisions on that date. He stated he did strike several chickens with the stick while he was attempting to gather them for euthanasia. He further stated he was not trained to use a stick while performing this function and he took it upon himself to commit the act. Faulkner will be charged with one count of misdemeanor animal cruelty via the attached complaint affidavit.

Photographs of the scene were taken and submitted to the Sheriff's Office Records section. Copies of all paperwork obtained during this investigation were also submitted to the Sheriff's Office Records section.

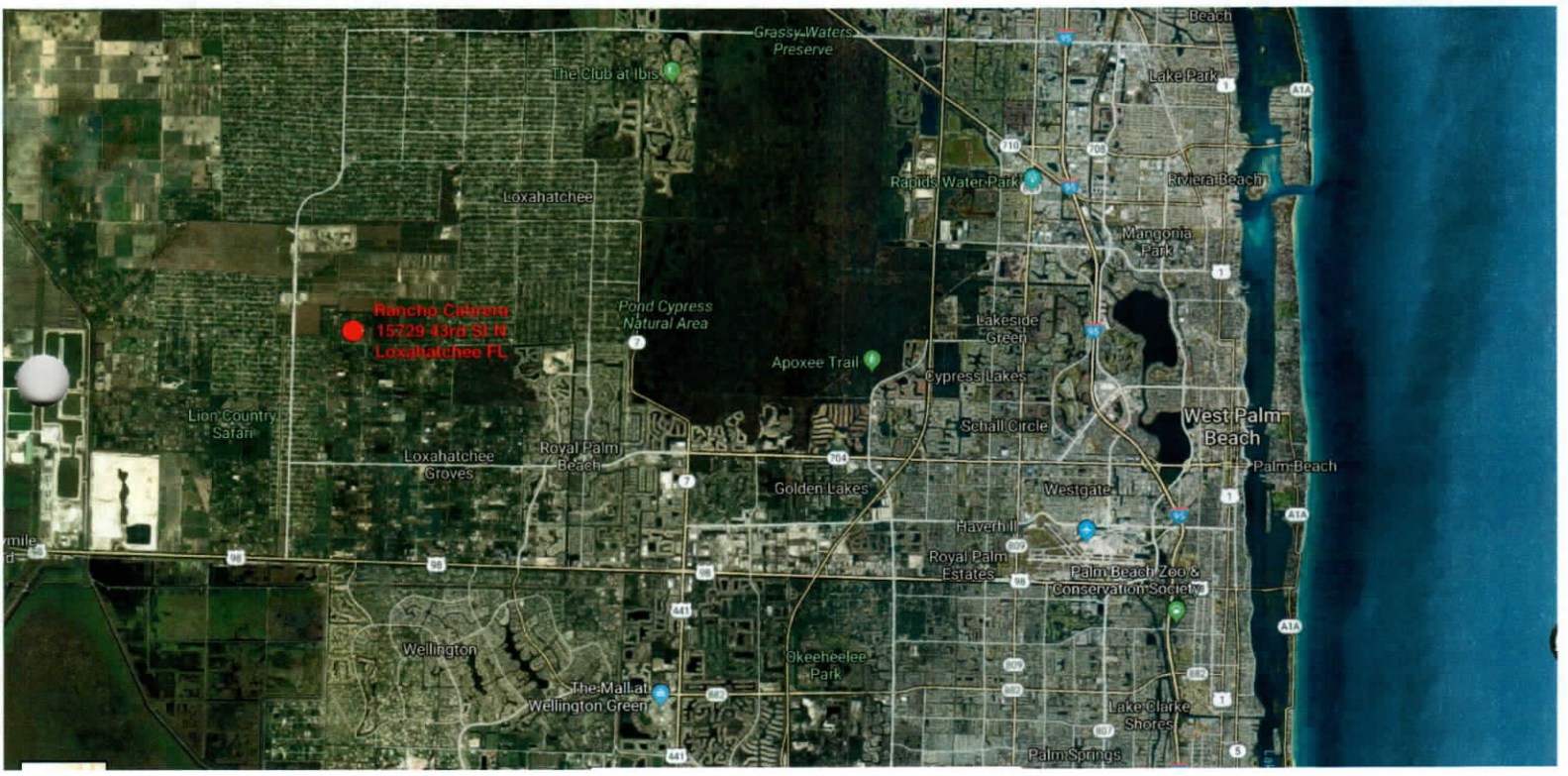

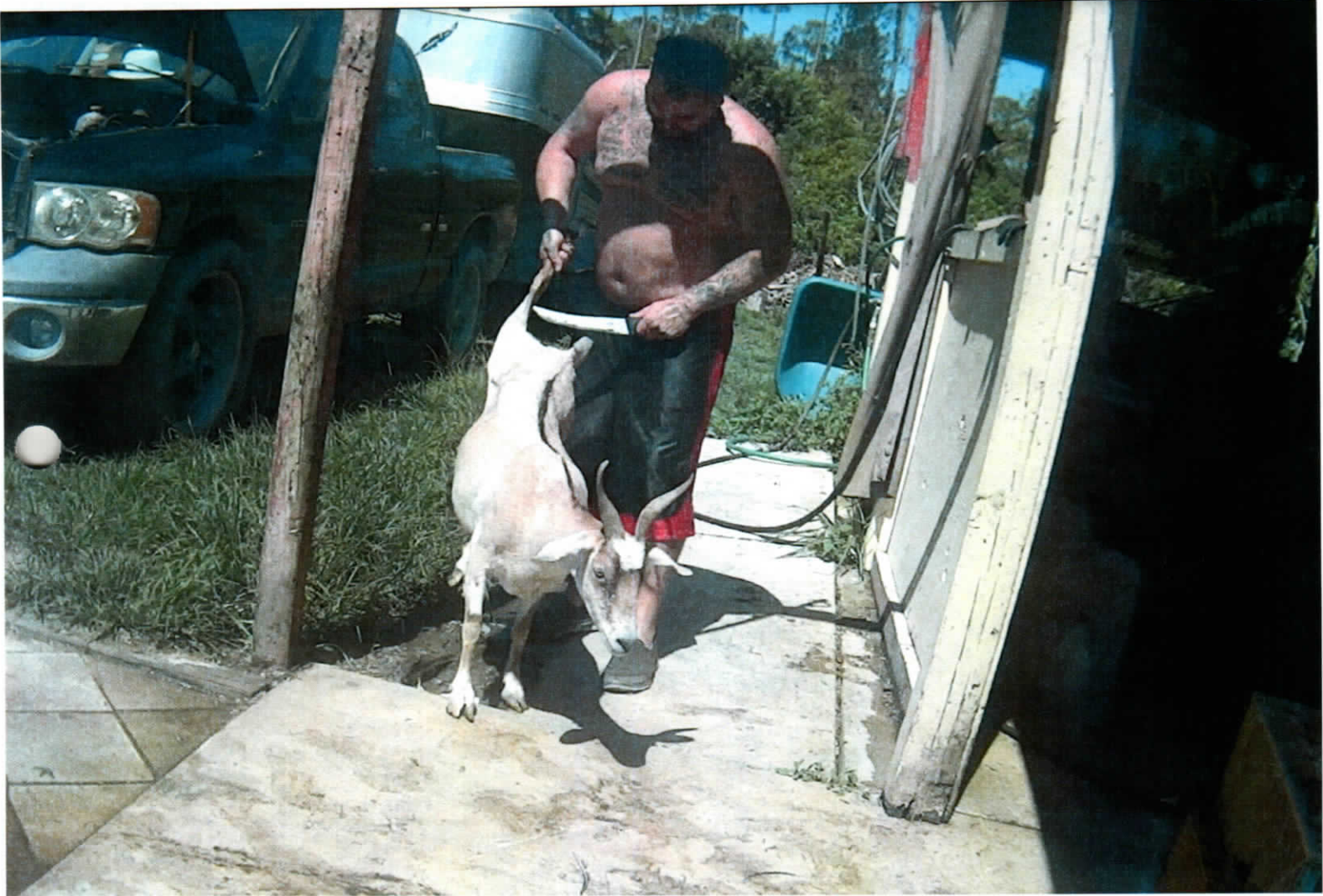

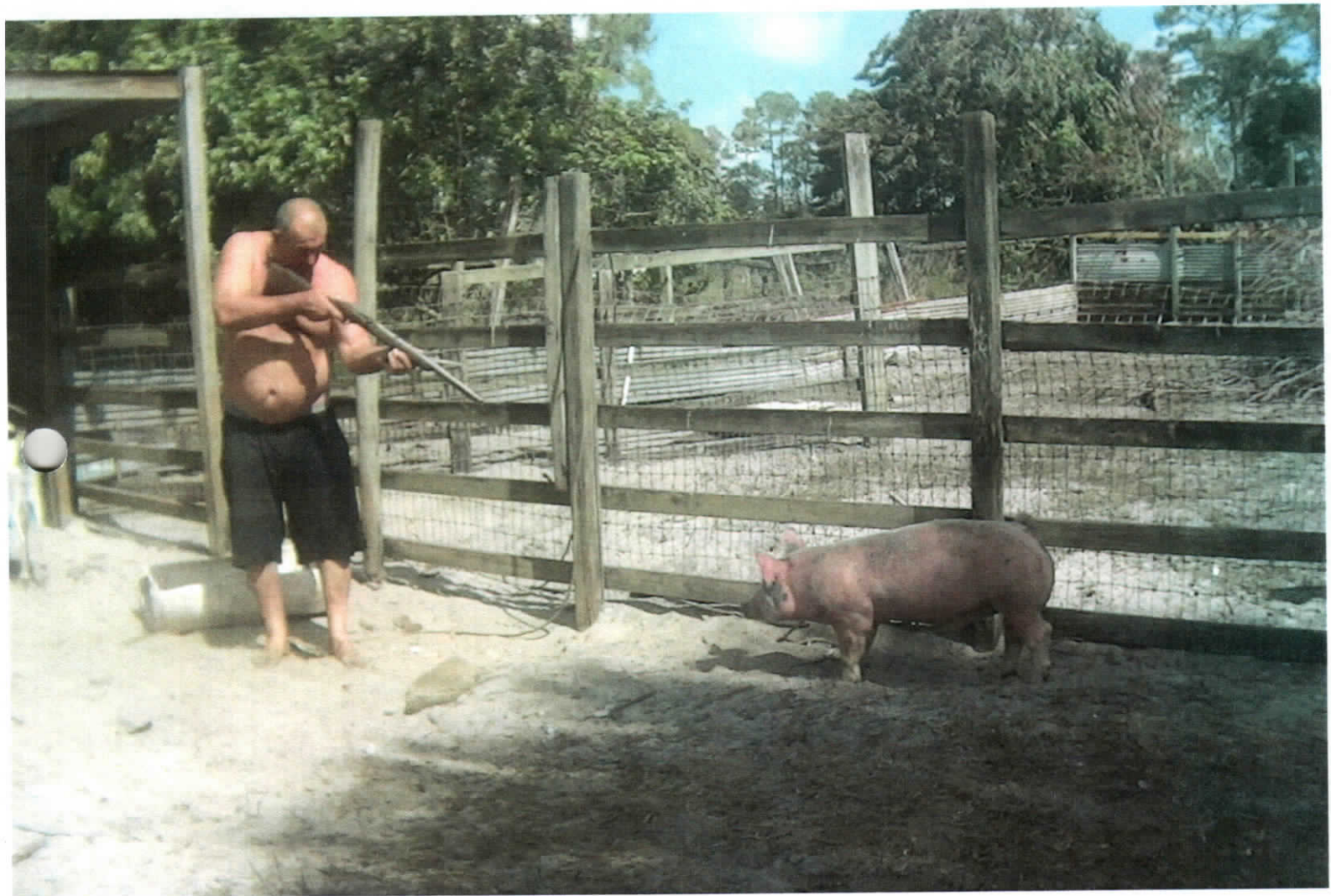
