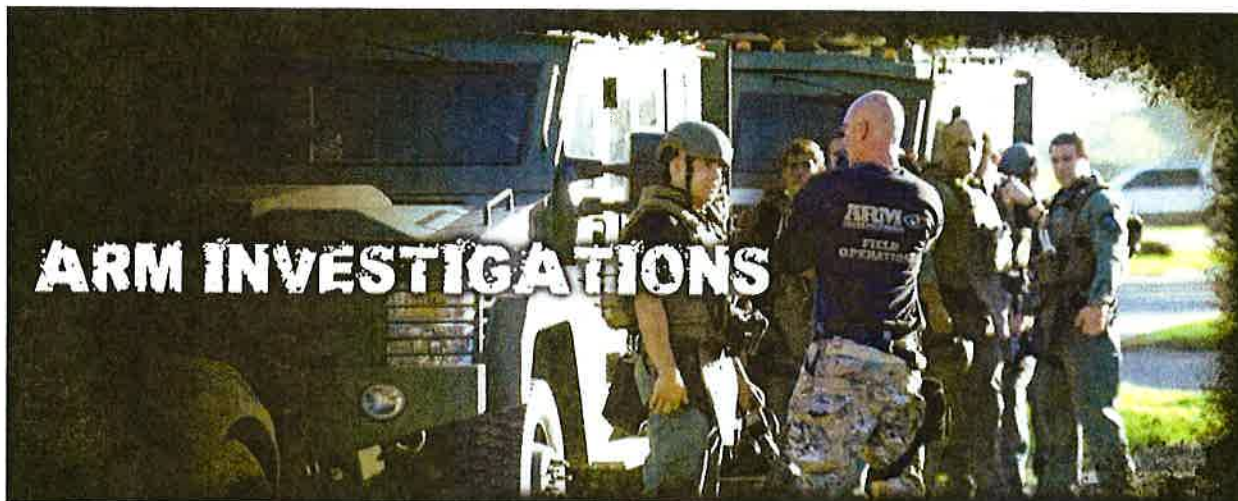

The Animal Recovery Mission (ARM), is a vanguard investigative animal welfare organization that was developed in 2010 by Richard Couto, shortly after he was exposed to one of Miami's darkest and most brutal animal cruelty operations. Upon this discovery of illegal animal slaughter farms and the black market horse meat trade, Couto, also known as 'Kudo,' invoked his vision of exposing and implementing solutions for extreme criminal acts towards animals into reality and created an unstoppable team who are dedicated to our organizations cause.

ARM Investigations has been carefully constructed as a direct-action organization. We conduct innovative investigative tactics to gather compelling evidence. ARM collaborates with local law enforcement, State attorneys, environmental protection agencies and The Animal Legal Defense Fund to produce concrete evidence to put an end to criminal acts involving animal torture.

ARM has since become the foremost expert organization in illegal horse slaughter. We specialize in condemning illegal animal slaughter farms in the United States. Our investigations, however, are not limited to slaughter farms as we are also actively investigating the black market horse meat trade, bestiality, underground animal fighting rings, fox & coyote penning games, and bear bile farms, to name a few, as well as the preservation of Wild Mustangs.

Succeeding in our investigations and exposing the truth as well as the eradication of these illegal practices have produced life changing results and permanent solutions. ARM's goals and vision is to constantly strive to raise the bar for the welfare of animals and to prevent and reduce their pain, fear and suffering.

As an organization we strive to be the defending force for destitute animals and to make significant improvements in how they are treated by exposing the truth, implementing laws to protect and educating the public on these illegal and barbaric practices. ARM prides it self on taking up the challenges that no one else will.

Our mission is to be an uncompromising defending force for the welfare of animals, in addition to putting an end to and preventing pain, suffering and torture inflicted as a result of inhumane practices.



OPERATION LEBO

In May 2023, Animal Recovery Mission (ARM) came across a Craigslist ad for animals and meat for sale. The ad included pictures and a description of the animals. The ad also had the owner's email and phone number for inquiries. The farm is advertising in the Fort Pierce, FL, area for selling meat and animals.

An ARM investigator reached out and requested to purchase meat, an address was given, and an appointment was made. When the ARM investigator made entry to the property at 3301 Brocksmith Rd Fort Pierce, FL it was apparent that this was a running illegal slaughterhouse where animals were purchased and then slaughtered for their meat by the owners and or farm workers. Miguel, one of the animal killers, suggested we follow him to another property where there were more animals to choose from. The ARM investigators was then led to 200 Godwin Rd., Fort Pierce, FL. Upon entry to this property, it was apparent that this site was also an illegal slaughterhouse selling animals for human consumption. The two properties, owners and farm workers work together in an organized criminal fashion. ARM investigators went to this property — multiple times to purchase animals for human consumption. The animals on the property are as follows.: cows, sheep, goats, dogs, cats, birds of all sorts, and pigs.

Roosters on site are for fighting purposes. They are also bred, raised, and trained to fight for fighting purposes. No animals were sold to ARM for ritualistic purposes. However, this is a service that the slaughter farm caters to.

ARM witnessed cows, goats, pigs, and birds slaughtered (unstunned) for human consumption. This violates both state and federal law. Blood from the killed animals is seeping into open ground throughout the slaughter and butcher areas. There is a possibility this is affecting the local groundwater in the greater area. Entrails of newly slaughtered animals are fed to other

animals and animals awaiting slaughter. Animals and body parts are being illegally buried, burned, and disposed of in trash and throughout the property. Both properties mentioned above are operating illegal businesses with no government oversight. There is no business licenses registered to either property, and proper business insurance has not been purchased.

Federal, State, and County laws violated are as follows:

- Animals are not stunned by an appropriate device or rendered unconscious and insensible to pain prior to the slaughter process, per the Humane Slaughter Act.
- Animals are inhumanely handled, dragged, hoisted, and butchered in front of other animals.
- Animals are choked and skinned alive.
- Dogs bite, and torment restrained animals awaiting slaughter.
- Goats, sheep, and pigs are stabbed repeatedly in the throat and chest with foot-long blades while screaming and thrusting, displaying clear signs of pain and life.
- Animals are conscious and aware as they are hoisted, skinned, and butchered.
- Waterboarding live animals.
- Throwing and slamming live animals.
- Animals, at times, have no clean or drinkable water.
- Animals are in poor health, emaciated, suffering from possible debilitating parasites, and untreated wounds.
- Meat from slaughtered animals onsite is sold illegally to off-the-street customers with no licenses or permits.
- Sale of unadulterated meat.
- Animals are butchered in unsanitary, illegal, open-air butcher areas, allowing the meat to be exposed to flies and insects.
- Contaminated meat from animals living in unsanitary conditions is entering the public food supply - a severe human health violation and risk of contagious disease.
- Animal carcasses are illegally disposed of in piles all over the property as vultures, ducks, and other flight birds feed and possibly spread infectious diseases to surrounding areas of the county and state.
- Animal skins, body parts, dead animals, and trash are strewn throughout the property.
- Unsafe living conditions
- Breeding, training, and fighting roosters.
- Zoning codes are being grossly violated.
- Animals are sold for ritualistic practices.
- No vet care is given to the sick, injured, or dying animals.

ARM witnessed and documented three felony acts of animal cruelty resulting in death and countless misdemeanor crimes during its investigation executed by Miguel and other ranch workers.

No one agency, city, county, state, or federal is or has been monitoring activities onsite for its duration.

ARM is requesting that all who took part in the crimes be arrested and prosecuted, the slaughterhouse closed down, torn down, and investigated by county, state, and federal agencies.

Under the State of Florida statutes, any and all animals living in such dangerous conditions must be rescued and brought to safety or sanctuary. ARM is extending an offer to give a safe haven to all remaining animals at the slaughter farm. ARM has taken part in over 200 similar operations with government agencies and will gladly aid in this case.

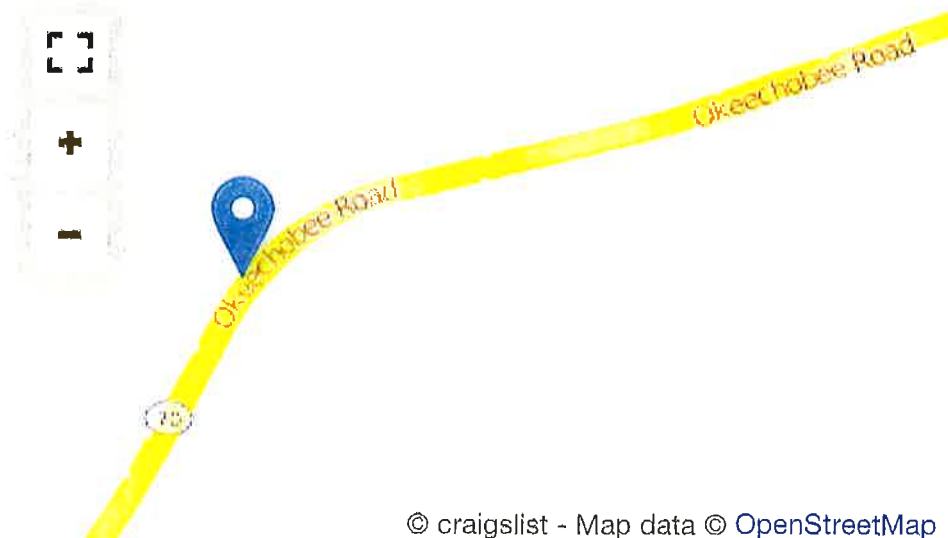

DeSantis goes on offensive in debate

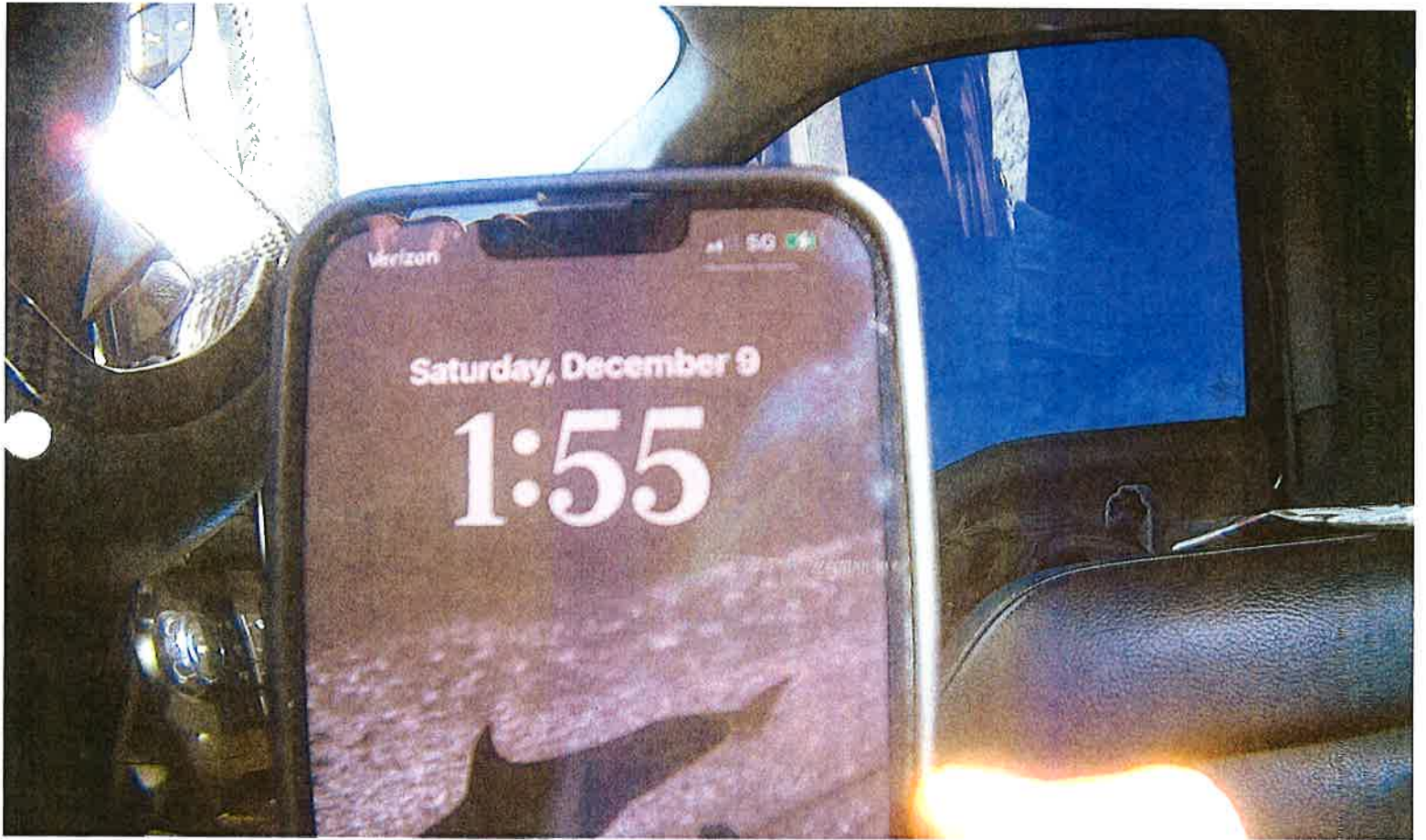
